Suprema Corte dos EUA encontra que ex-presidentes têm imunidade presuntiva de processamento por "atos oficiais"

A Suprema Corte dos EUA decidiu esta semana que ex-presidentes têm imunidade presuntiva de processamento por "atos oficiais". Essa decisão não apenas coloca Donald Trump acima da lei, mas o verdadeiro perigo da opinião é que poderá proteger atos oficiais que poderiam destruir a própria república americana.

Imunidade de atos oficiais

A ideia de que os atos oficiais de um presidente são imunes ao processamento tem origem site de apostas lotofácil um caso sobre um denunciante demitido indevidamente. Em 1970, o presidente Richard Nixon demitiu A Ernest Fitzgerald, um analista de gestão da força aérea, site de apostas lotofácil retaliação por divulgar informações sobre superfaturamento. Fitzgerald entrou com uma ação civil contra Nixon, buscando indenização por site de apostas lotofácil demissão. A Suprema Corte decidiu a favor de Nixon, concedendo imunidade absoluta ao presidente contra "responsabilidade financeira decorrente de atos oficiais".

Na época, a Suprema Corte definiu "atos oficiais" como aqueles associados aos deveres do presidente sob o artigo II da constituição, incluindo o dever de "garantir que as leis sejam fielmente executadas". Afirmou a imunidade mesmo para atos presidenciais no "perímetro externo" desse dever. No entanto, neste caso, a corte se concentrou site de apostas lotofácil isolar um presidente de preocupações sobre site de apostas lotofácil responsabilidade financeira, de modo a facilitar as decisões sobre assuntos diáriamente de governança, como contratação e demissão.

Na época, a Suprema Corte não definiu esses atos oficiais para incluir *crimes* cometidos por um presidente. De fato, site de apostas lotofácil decisão estreita excluiu apenas o "particular meio de recurso privado" de uma ação civil contra um ex-presidente e mesmo incluiu uma promessa de "não colocar um presidente acima da lei".

Esta semana, a decisão distorceu grossamente a decisão Fitzgerald, desprezando essa promessa. Em vez disso, estendeu uma opinião sobre imunidade de danos civis a processos criminais para abranger a imunidade criminal para atos contrários ao dever do presidente de "tomar conta". O perigo da imunidade para a ação criminal oficial é que protege o enorme poder do presidente quando é usado para os fins políticos mais nefastos, ameaçando a própria existência da democracia.

Ato oficial versus ato privado

Atos privados não são a razão pela qual a questão da imunidade importa. Os atos mais perigosos de um presidente são aqueles que são oficiais. Considere a advertência da juíza Sonia Sotomayor site de apostas lotofácil site de apostas lotofácil dissidência contundente de que a decisão poderia proteger um presidente que tenta usar o exército ilegalmente para manter o poder após perder uma eleição, o que os cientistas políticos chamam de "golpe de estado". Nenhum tribunal deve incentivar ações que possam ameaçar a estabilidade mesma da república.
